

CMP SERVICE RIFLE MATCH

SPONSORED BY:

THE MONTANA RIFLE AND PISTOL ASSOCIATION

DATE: Sept 2, 2018. Firing will begin at about 9:00AM. Registration will begin at 7:00 AM and closes at 8:15AM. This range faces East and shooting into bright sun is a safety hazard. This match may be delayed up to ½ hour if the sky is clear and sun is bright. The decision to delay the match will be put to the jury and their decision will be final.

LOCATION: Butte Gun Club's Rocker Range (go to www.buttegunclub.org for map and directions to range, and range schedule) The combination on the main gate is **call**.

On the day of the match post entries will be received in the white Schutzen House on the range. Advance entries not confirmed and paid by 8:00AM will be forfeit. Post entries will be accepted up to the capacity of the range which is 36 shooters.

ELIGIBILITY: This match is open to any able bodied citizen of the United States who is 12 years of age or older (age requirement may be waived) and has not been convicted of a State or Federal felony or violation of section 922 of Title 18 USC. Before an individual is allowed to compete the club will have on file a notarized affidavit from the individual stating he or she has not been convicted of Fed or State felony or violation of Sec 922 title 18 of USC and is not a member of any organization that advocates the overthrow of the US government.

ELIMINATION: The Executive Officer may at his discretion and by such standards as he may prescribe eliminate competitors of lowest standing at any time after the first stage of the match.

ENTRY FEE: The Entry Fee is \$10.00 per competitor. (CMP receives this fee)

LOADING PROCEDURE: Stages 1 & 4 are Slow Fire and only one round maybe loaded in the rifle at a time. Targets are pulled and marked between shots. Stages 2 & 3 are Rapid Fire. Two magazines will be loaded; one with 2 rounds and one with 8 rounds. At the command for shooters to "Stand" and "With bolts closed on an empty Chamber – Load" the shooter will stand, close the bolt and insert the 2 round magazine. M-1 shooters will load a 2 round clip into the magazine and depress the top round so that the bolt closes on an empty chamber (2 round clips are very handy). When the shooter takes the firing position he/she cycles the bolt and fires the 2 shots. He/she then reloads and fires the magazine or clip with 8 rounds.

COURSE OF FIRE

Stage 1 – Standing, Slow Fire, 10 record shots, time - 10 min, target - SR, 200 yds.

Stage 2 - Sitting or Kneeling from Standing, Rapid Fire, 10 rec shots, 60 sec, target - SR, 200yds.

Stage 3 - Prone from Standing, Rapid Fire, 10 record shots, 70sec, target - SR-3, 300 yds.

Stage 4 - Prone, Slow Fire, 20 record shots, time - 20 min, target - MR-1, 600yds

RULES: The 2018 CMP Competition Rules and Guide to CMP Programs will govern this tournament. **Note: CMP rules differ from NRA rules! All competitors will start the Rapid Fire Stages in the standing position.**

SAFETY: Use of an ECI – “Empty Chamber Indicator” is required in all matches. ECI’s may be purchased at registration. Eye and ear protection is required in the Pits and on the firing line and is encouraged for anyone in the vicinity of the firing line while firing is taking place.

AMMUNITION: Ammunition will not be provided by the CMP. Competitors are responsible for providing their own ammunition. Ammunition in cal .30 (30-06), 7.62mm (.308 Win), 5.56 mm (.223 Rem) or cal .30M1 (30 Carbine) must be used in this match. Service, commercial or hand loaded ammunition is authorized.

NM WEAPON: US Rifle cal .30, M1; US Rifle cal 7.62mm, M-14; US Rifle M1 modified with 7.62mm cal barrel and NM versions of the above weapons: US Rifle cal 5.56mm, M-16 may be used. US Rifle M-110 cal 7.62mm may be used. The commercial equivalent of these weapons may be used provided they have not less than 4 1/2 lb trigger pull and otherwise conform to their military counterparts specifications. See 2017 CMP rules specific to the NM versions and modifications authorized to the above weapons. 4.5X scopes are now allowed on AR 15 service rifles.

AWARDS: Credit toward the ***DISTINGUISHED HIGH POWER BADGE*** for those finishing in the top 10% of the non-Distinguished shooters entered. There are no separate classes for NM or “as-issued” weapons. Only those competitors who start both Rapid Fire Stages from the “Standing” position will be counted when calculating non-Distinguished Shooters entered.

NOTES: No lunch service is available at the range. Competitors may camp at the range while attending these matches. Set up tents and trailers in the vicinity of the log cabin. Water and sanitary facilities are limited. The Rocker Inn and Motel 6 are located at the Rocker, MT exit of I-90/I-15. Truck Stop cafes are at the interchange. (approx 1 mi)
